If the noise "*is disturbing your peace*", call the police non-emergency line **619-531-2000**. Report the exact address and ask the dispatcher for the event #. Keep a record.

Photograph it and record the location and date. Report on it on “GET DONE SAN DIEGO” with the photo. The photo will be entered in the Graffiti Tracker Database. If you remove it, note that in the report.
